Both children enjoy learning and want to do well in their studies. Their favourite subject is English and they like ball games.

Their parents are very happy and grateful to Tender Heart for giving their children a chance to have a good education, where they can learn English. This will help the children to gain entry into government schools and eventually obtain good jobs to provide for their future and lift them out of the slums and poverty.
